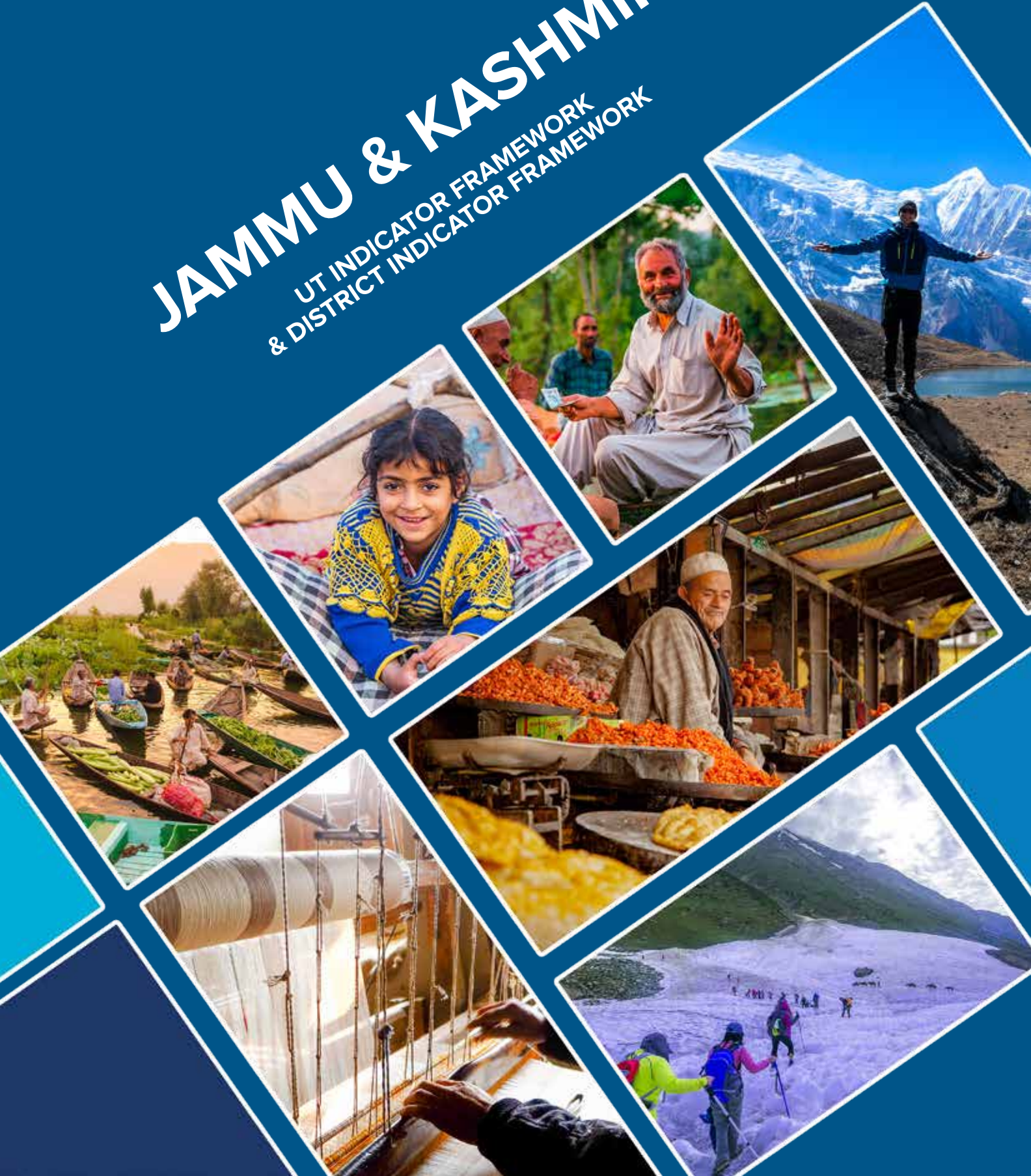

EXECUTIVE SUMMARY:

SUSTAINABLE DEVELOPMENT GOAL

Sustainable Development Goals have steered the development goals and strategies at global and national level in the last five years. The 70th Session of the United Nations (UN) General Assembly held on 25th September 2015 adopted the document titled “Transforming our World: the 2030 Agenda for Sustainable Development” comprising 17 Sustainable Development Goals (SDGs) and associated 169 targets. The SDGs seek to address not only the root causes of poverty but also the universal need for development to provide a life of dignity to all.

The SDGs encompass all the key development sectors including education, health, sanitation, employment, infrastructure, energy, and environment. SDGs are derived from the unfinished agenda of Millennium Development Goals (MDGs) as they were limited to certain aspects of social and economic development. Countries have the primary responsibility for follow-up and review, at the national, sub-national and lower levels regarding the progress made in implementing the goals and targets till 2030. Though not legally binding, the SDGs have become de facto international obligations and will re-orient domestic spending priorities till 2030. Implementation of SDGs and their success will rely on countries own sustainable development policies, plans and programmes. In addition, given the complexity of the SDGs, there is an unprecedented demand for data on national and sub-national statistical systems. SDGs are the blueprint to achieve a better and more sustainable future for all. They address the global challenges we face, including those related to poverty, inequality, climate change, environmental degradation, peace, and justice. The 17 Goals are all interconnected and to leave no one behind, it is important that we achieve them all by 2030.

MULTIDIMENSIONAL POVERTY INDEX (MPI)

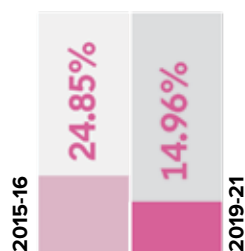
The National Multidimensional Poverty Index plays a pivotal role in assessing advancements towards target 1.2 of the Sustainable Development Goals (SDGs) which aims at reducing “at least by half the proportion of men, women, and children of all ages living in poverty in all its dimensions”. NITI Aayog published the national MPI Baseline Report in November 2021, with estimates computed using the data from the 4th round of the National Family Health Survey (NFHS-4) conducted in 2015-16. The dual-cutoff approach of the AF methodology – the one used in the Global MPI Report – was considered suitable for the national MPI. The national MPI model retains the ten indicators of the global MPI model, staying closely aligned to the global methodology. It also adds two indicators, viz., Maternal Health and Bank Accounts, in line with national priorities.

A National MPI Progress Review 2023 presents the second edition of the national MPI and is a follow-up to the Baseline Report published in November 2021. It provides multidimensional poverty estimates for India’s 36 States & Union Territories, along with 707 administrative districts across 12 indicators of the national MPI. These estimates have been computed using data from the 5th round of the NFHS (NFHS-5) conducted in 2019-21, employing the same methodology as the baseline report. This edition also presents the changes in multidimensional poverty between the survey periods of NFHS-4 (2015-16) and NFHS-5 (2019-21). The MPI serves as an important tool that enables the country to track its progress towards the Sustainable Development Goals (SDGs), particularly SDG target 1.2, that aims to reduce poverty in all its dimensions.

The Multidimensional Poverty Index (MPI) has been used by the United Nations Development Programme (UNDP) in its flagship Human Development Report since 2010 and is the most widely used non-monetary poverty index in the world. It captures overlapping deprivations in health, education and living standards. **The MPI complements monetary poverty measures by capturing additional information – including broader qualitative aspects of life, like child mortality, housing conditions, and other basic services such as water and sanitation.**

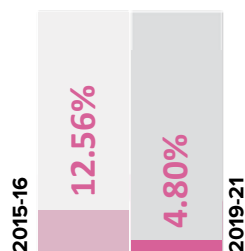

NATIONAL INDICATOR FRAMEWORK (NIF)

The Government of India has played a leading role in defining the contours of the sustainable development agenda and is committed to achieving the SDGs in a time bound manner. At the national level, NITI Aayog is mandated with the task of coordinating work on SDGs by involving central ministries, states & union territories (UTs), civil society organizations, academia and business sector to achieve India's SDG targets. The Ministry of Statistics and Program Implementation (MoSPI) has developed a consolidated list of possible national indicators to create a framework for monitoring SDGs at the national level. The NIF is the principal monitoring framework in the country and has been shared with all States. It comprises national targets, national indicators, and centrally sponsored schemes, which directly or indirectly contribute towards attaining the SDGs. The framing of the National Indicator Framework was done in a consultative manner with all the Ministries/Departments to have a robust framework. At present, there are 284 indicators in the NIF, 2023. At the National level, MoSPI coordinates with the data source Ministries/ Departments for getting data on SDG indicators in NIF.

The NIF is the culmination of a series of interaction with data source Ministries/ Departments together with UN organizations for adopting/adapting more global indicators and modifying a few national indicators.

Continuing the practice of yearly updating and reporting, the Sustainable Development Goals – National Indicator Framework 2023 has been prepared after taking inputs from all the data source Ministries/Departments.

UNION TERRITORY INDICATOR FRAMEWORK

Apart from the national targets, states and Union Territories have additional priorities depending on their local context, situations, and priority areas. To meet the global, national, and state/UT level expectations, the State/UT Governments are delegated the task of developing the State/UT Indicator Framework in tune with the NIF. The UTIF is pertinent towards monitoring UT Government's priorities, schemes, strategy and action plan towards achieving SDGs 2030. Significant progress has already been made in the state of Jammu & Kashmir in recent years with respect to work on SDGs, however this tempo must be deliberated in an evidence-backed manner to fully achieve the set targets. The UT Indicator Framework is evolutionary in nature akin to the Global Indicator framework and National Indicator Framework, where the number and type of indicators have evolved over time. The Jammu & Kashmir UTIF is a comprehensive framework, which has been developed while aligning to all the guidelines laid out by the MoSPI. With a vigorously followed process, the Jammu & Kashmir UTIF will be the backbone of monitoring SDGs at the State level and provide opportunities for evidence-based policy making and implementation in the State.

Different departments of the Government of Jammu & Kashmir are responsible for the development of state/UT level policies, strategies, schemes, and their implementation in their respective work areas and subsequent contribution towards achieving one or more SDGs. The annual budget is also proposed by each department; hence their efforts need to be accounted for and monitored through a state/UT level framework.

For the UT Indicator Framework of Jammu and Kashmir, 228 indicators are listed. Collecting data from the departments for UTIF for the current year 2022-23 is currently in process. The first part lets us view Jammu and Kashmir's performance on each SDG and compare UT's performance to India's and the best-performing scores.

DISTRICT INDICATOR FRAMEWORK (DIF)

For the District Indicator Framework of Jammu and Kashmir, 159 indicators are listed. We are collecting data from the districts on the designated District Indicator Framework (DIF) for the years 2020-21, 2021-22, and 2022-23 to know what the trends of all listed indicators are. To evaluate the performance of districts on SDG the district indicator framework has been developed. District Indicator Framework has been prepared after reviewing the schemes of departments and alignment of indicators with the SDG Goals and Targets against the UT Indicator Framework. DIF is used for regular monitoring by the concerned DM & Collectors in the Districts for achieving the SDGs. Also prepared based on the input received from the concerned line Departments and included in the document.

METHODOLOGY

Steps taken by MoSPI in bridging data gaps

MoSPI has taken several steps in bridging the data gaps relating to SDG indicators. The Ministry holds regular consultations with line Ministries/Departments and the respective Custodian Agencies.

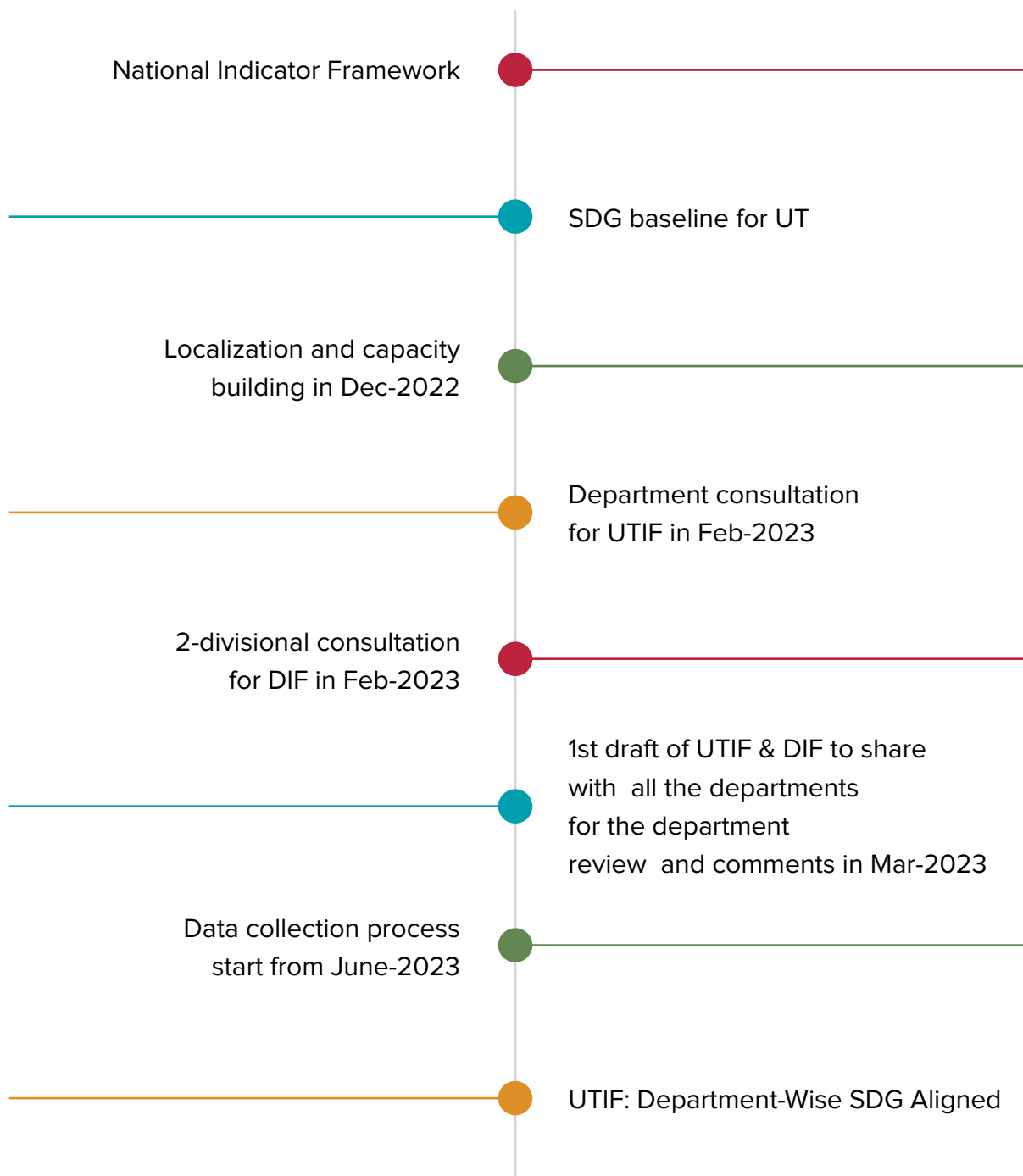
To institutionalize such deliberations, MoSPI, NITI Aayog and the United Nations represented by United Nations Resident Coordinator Office (UNRCO), New Delhi, India have entered into a Tripartite Memorandum of Understanding (MoU) relating to support for Data, Indicators and Statistics for monitoring Sustainable Development Goals (SDGs) in India.

The overall purpose of the MoU is to collaborate on issues related to support for statistical monitoring of Goals and Targets of SDGs, including the use of new technologies, capacity development to track SDG related outcomes and any other emerging requirements.

Subsequently, in pursuance of the provision of MoU, MoSPI has set up a Data for Development Coordination Forum (DDCF) on SDGs, under the co-chairmanship of Director General (Statistics), NSO, MoSPI and UN Resident Coordinator for developing the data plan, assisting in the development of a sound measurement, improving the indicator framework after a thorough review with all stakeholders, etc. This is a vital forum to discuss the SDGs related issues with all the stakeholders and UN Agencies at a unified platform.

In order to bridge data gaps on SDGs, MoSPI has launched certain surveys and aligned some of its existing surveys, like Periodic Labour Force Survey (PLFS), etc., with SDGs as per its data requirement.
